

Voting by Mail-in Ballot

Mail-in ballot applications for the April 28, 2020, primary election must be received by your <u>county election office</u> by 5 p.m. on Tuesday, April 21, 2020.

How do I apply for a mail-in ballot?

Option 1: Apply for a Mail-in Ballot Online



Apply Online at VotesPA.com/ApplyMailBallot

Registered voters can apply for a mail-in ballot online with a <u>valid PA driver's license or</u> <u>photo I.D.</u> from the PA Department of Transportation (PennDOT).

Military and overseas voters should visit the <u>information for military and overseas voters</u> web page for information on how they can obtain an absentee ballot.

CHANGES TO CANDIDATE GRANTS POLICIES

The good news from the 2018 election was, almost 90 women ran for state and federal offices in PA. The bad news was, PFDW's PAC funds were stretched so far that we couldn't help most candidates as much as we wanted to.

The PFDW Board reviewed our policies. What is best to do? Do we give every woman running in the state a few dollars, or do we focus on certain races with larger contributions? If we set a focus, which races do we pick?

Because we are a statewide organization, our PAC will continue to support women running for federal and statewide offices. We will reach out to every woman who wins one of those primaries.

For our PA Legislative races, we made the decision to concentrate on areas where we have clubs. PFDW's strength is in our clubs; this Board wants to work more closely with them. Club members are in the best position to call the Board's attention to talented women candidates, and to help those candidates win. Together, we can form a partnership of volunteers and funding.

Do we have clubs in every part of the state? No—but we'd like to! Our Regional Directors are ready to help form new clubs.

As always, we make no grants until after the Primary election, but we want you to know now that we will be reaching out for your club's guidance. Expect a revised application from us after the Primary.

Region 8 – Berks, Lehigh and Northhampton Democratic Women President: Linda Woleslagle

(Summary from Reading Eagle Newspaper Article - by Ron Devlin)

The role African-American women played in bringing about the passage of the 19th Amendment was outlined at Thursday's meeting (2-20-2020) of the Berks Democratic Women in the Inn at Reading, Wyomissing.

Priyak Aitken, who chairs the young women sector of the organization, gave a detailed history of the struggle African American women underwent to achieve the right to vote for all women.

Mary Church Terrell was one the few African American women who was active in the National American Suffrage Association, whose founders included Susan B. Anthony and Elizabeth Cady Stanton.

Ida B. Wells, an investigative journalist who wrote about lynchings, was also an outspoken advocate for women's suffrage.

Anna Julia Cooper, a prominent African American scholar, was a strong supporter of suffrage in her teaching, writing and speeches. The U.S. Postal Service honored her with a commemorative stamp in 2009.

Aitken, 32, an Exeter Township engineer, said the road to suffrage was not a smooth one for African American women. "African American women", she said, "were often left out of the suffrage movement."

Aitken's presentation marked the 100th anniversary of the adoption of the 19th Amendment, which gave women the right to vote.



Billed as the Berks Democratic Women's Forum, the meeting included a presentation by Dr. Noahleen Betts, director of

podiatry at the Berks Community Health Clinic in Reading. Dr. Betts, a member of the Reading School Board, recently returned from a mission to provide medical care in rural Puerto Rico.

Robin Costenbaden-Jacobson, President of Reading School Board, is running for Democratic nomination as state representative in the 127th Legislative District. Costenbader-Jacobson vowed to work to end homelessness, improve treatment for mental illness and end gun violence. "Blacks are 10 times more likely than whites to die of gun violence".

Kadida Kenner, director of <u>Why Courts</u> <u>Matter Pennsylvania</u>, focused on the threat of voting and reproductive rights due to the

If you have a recipient from your club, remain in touch with her and encourage her to remain involved in Democratic politics. Work with the State or local party to form an organization of Young Democrats, or get to know the existing club. Even if there is no "formal" Young Democrats club, continue to identify young women in your community who are interested in becoming involved in the Democratic Party. Be a mentor to young women; encourage your State or local organization to hold political trainings for Trump administration's appointments of conservative federal judges and potential appointment to the U.S. Supreme Court.

them. If there is a YD club, support it and attend its events. Encourage our Women's Democratic organizations to use social media more extensively to reach younger members. Schedule a YD speaker at a club event; ask the Young Democrats to schedule a Federation member to speak at their events; ask if you can set up an information table. Network – network – network – find out what other Democratic Women's organizations do to encourage younger members. Find out from younger members what they are looking for in these organizations. Know the issues that are important to them.

Region 15 – Democrat Women of Mercer County (DWMC) President: Kim Powell




